Dear Block Party Applicant:

The following is a list of information required to process your application for a Block party/road closure:

- Date of event
- Rain date
- Start/finish times
- Street(s) to be closed and locations of closures/barricades
- Letter of notification signed by residents living within the affected area
- Contact information for applicant (Block Party Notification form included)

This information must be forwarded to the Wall Township Police Department Special Services Division four weeks prior to the event for a Street Closing Proclamation.

Cones and barricades may be available through the Department of Public Works (732-449-2700).

Applicants must keep a minimum of a 12 foot path through the designated roadway to ensure passage of emergency vehicles if necessary.

Applicants must read, understand, and comply with Township Ordinance 22-2014 Peace and Good Order under Chapter 164 in reference to Noise Control 164-2(D)(1). Which states the following will be a violation *"Any unreasonable loud and disturbing sounds such as, but not limited to, the playing of music or amplified sound of any type, crowd noise or loud conversations or celebrations which transmits beyond the bounds of property from which they emanate, shall be prohibited when carried between the hours of 11:00 p.m. Friday night and 7:00 a.m. Saturday morning and, between the hours of 11:00 p.m. Saturday night and 7:00 a.m. Sunday morning. On all other days those same acts shall be prohibited from 10:00 p.m. at night until 7:00 a.m. the following morning. For day proceeding legal holidays and for legal holidays the hours applicable to Fridays and Saturdays listed in this subsection shall apply (11:00 p.m. at night until 7:00 a.m. the next morning.)"*
